



# GIFT AID DECLARATION FORM

*giftaid it*

Gift Aid is a scheme that allows York Christian Youth Holidays (YCYH) to reclaim tax on every £1 gift you make to us from the Inland Revenue.

- For donations given up to 5 April 2008 YCYH can reclaim 28p on every £1 gift you gave.
- For donations made on or after 6 April 2008 YCYH can reclaim 25p on every £1 gift you give.
- In addition the Government will also pay YCYH an additional 3p on every £1 you have given between 6 April 2008 and 5 April 2011. This transitional relief for the YCYH does not affect your personal tax position.

**Notes:** You must pay an amount of Income Tax and/or Capital Gains Tax for each tax year (6 April one year to 5 April the next) that is at least equal to the amount of tax that YCYH will reclaim on your gifts for that tax year.

If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that the charity reclaims, you can cancel your declaration.

If you pay Income Tax at the higher rate, you must include all your Gift Aid donations on your Self Assessment tax return if you want to receive the additional tax relief due to you

If you are unsure whether your donations qualify for Gift Aid tax relief, ask the charity. Or, refer to help sheet IR65 on the HMRC web site. ([www.hmrc.gov.uk](http://www.hmrc.gov.uk))
